Addressing the issues of advocacy and shared values between the two groups, Torres-Gil will be the keynote speaker for the CCoA/SILC public meeting scheduled for December 7, 11:00 a.m. at the Doubletree Hotel San Francisco Airport in Burlingame. This meeting marks the third time that SILC and CCoA have met together to identify issues of concern to both constituencies. Alzheimer's Disease Facts and Figures in California: Current Status and Future Projections

A new report posted by the State Alzheimer's Disease and Related Disorders Advisory Committee projects dramatic increases in Alzheimer's disease in California over the next 20 years. The 2010 report *Alzheimer's Disease Facts and Figures in California: Current Status and Future Projections* predicts that the baby boomer generation is as likely to define our state's future as it has California's past. As this enormous demographic group ages and lives longer than previous cohorts, a significant increase is expected in the numbers of people diagnosed with Alzheimer's. Compiled by the US San Francisco Institute for Aging and Health, the report provides an overview of the full range of implications on families, our state's human service infrastructure and its economy. The next meeting of the State's Alzheimer's Disease and Related Disorders Advisory Committee will be November 17 in Sacramento. The Committee was established in 1998 to advise the Administration and Legislature on Alzheimer's disease-related issues and public policies.
