### 8. CCoA Sponsored Bill Update

Smith provided an update on the status of each of the Commission's sponsored bills.

- A. AB 1993 (Kalra) Residential care facilities for the elderly The amended bill passed Assembly Appropriations.
- B. AB 2207 (Reyes) <u>State boards and commissions: seniors</u>
  It was noted again that if HCAI will add cost, the bill will be amended to remove that council.
- C. AB 2620 (Bains) <u>California Commission on Aging</u> Former Commissioner Rita Saenz testified in Senate Human Services today on June 3 on behalf of CCoA.
- D. SB 1249 (Roth) Mello-Granlund Older CA Act
  The bill passed the Senate and is referred to the Assembly Aging and
  Long-Term Care Committee. Currently, the author, Commission, and
  California Department of Aging staff are working with opposition to
  address concerns. Amendments are forthcoming.
- E. Senate Concurrent Resolution 153 (Dodd) <u>Elder and Dependent Adult Abuse Awareness Month</u>
   CCoA sponsored a resolution in honor of World Elder Abuse Awareness Day.

## 9. Legislative Advocacy Committee Update

  legislation. Staff reported work will begin with the Legislative Advocacy
  Committee in early fall to identify potential bill concepts. Any
