Jeannee Parker Martin is the President and CEO of LeadingAge California, a Sacramento-based association focused on improving housing, care, and services for older adults. She oversees the organization's strategic direction, operations, and advocacy efforts for over 800 member organizations throughout California. Commissioner Martin has testified before state and federal agencies and contributed to the President's Coronavirus Commission on Quality and Safety in Nursing Homes and the California Governor's Master Plan for Aging Stakeholder Advisory Committee. With her extensive background in healthcare, leadership, and advocacy, Commissioner Martin's insight will be invaluable to the Commission as it continues its work to improve the lives of older Californians.
