Dear Drs. Ghaly and Angell,

As the principal advocate for older Californians designated in Welfare and Institutions Code, the California Commission on Aging must express our strong opposition to the Health Care Surge Crisis Guidelines re-issued by Dr. Angell on April 29, 2020.

We recognize there were some improvements in the revised guidelines to specify that allocation of scarce medical resources during a public health emergency should be based on individualized patient assessments, without regard to age, disability, race, sex, sexual orientation, gender identity, immigration status or other factors. However, this guidance is not applied consistently throughout the document. Our greatest concern is the application of "saving life years" and "life cycle" considerations when resolving ties to prioritize patients, which is blatantly and illegally ageist.

One person who might have been discriminated against under this policy is the stepmother of a Commissioner who was diagnosed with HIV in her late fifties. What sort of a life cycle would have been predicted for her? She lived to be 88.

It is equally concerning that an Administration that has provided such extraordinary leadership with the initiation of the Master Plan for Aging and the Equity Workgroup, would produce guidance that illegally discriminates against older Californians.

We request you immediately revise the guidance to remove any discriminatory language to ensure an unbiased allocation of resources, without regard to age or disability. We also recommend that older adults and organizations representing this population be meaningfully engaged in the development of policies that impact our community.
